3a	<p>Through its George Melendez Wright Student Travel Scholarship program, the GWS provides travel assistance to enable undergraduate and graduate students from under-represented racial and ethnic groups to attend the GWS biennial conference. Students fill out an on-line application in which they identify themselves according to racial/ethnic affiliation and state how they think their attendance at the GWS conference will benefit them in their further studies and/or in a potential career in parks and protected areas. A scholarship screening committee, authorized by the GWS Board and containing at least one GWS Board member, reviews applications, evaluates them for quality, and recommends a list of awardees to the GWS Board, which then authorizes the grants.</p> <p>Through its Native Participant Travel Grant (NPTG) program, the GWS enables Native protected area professionals from North America to attend the GWS biennial conference. An NPTG screening committee, authorized by the GWS Board and containing at least one GWS Board member, reviews applications, evaluates them for quality, and recommends a list of awardees to the GWS Board, which then authorizes the grants.</p>
